FIRST QUARTER 2006 KEY OPERATING DATA

Moscow, Russia – May 12, 2006 – COMSTAR – United TeleSystems (Comstar UTS) today announced the key operating data for its alternative and traditional fixed line telecommunications business segments for the first quarter of 2006.

HIGHLIGHTS

(31 March 2006 compared to 31 December 2005)

- 3.62 million traditional fixed line subscribers and 4.7 million installed lines by end of the quarter
- 5% increase in total number of active subscribers in Moscow to 500,657
- 14% increase in broadband Internet subscribers in Moscow to 283,307
- Doubling of 'Stream TV' Moscow broadband pay-TV subscriber base to 14,300

Semyon Rabovsky, Chief Executive Officer, commented: "We continued to grow our overall subscriber base during the quarter, which is a seasonally slower period of the year, with a particularly strong performance in the Moscow market. Our broadband internet and pay-TV offerings have benefited from the integrated 'Stream' triple play branding, and both grew rapidly in the quarter as a result of both up-selling existing dial-up customers, as well as new sales. Our outlook for the year remains positive and we expect to see strong demand for our services in Moscow and further growth in our total subscriber base, with a particular emphasis on rolling out our broad range of services outside Moscow."
